

Job Description:

- Operate material-moving equipment including forklift, pallet jacks and hand truck
- Distribute materials to fellow employees as needed
- Process and inspect all incoming shipments for accuracy and quality
- Attach identification information to products, items or containers
- Pack, unpack, and label stock items and containers using identification tag or other labeling. equipment
- Receive and fill orders as necessary
- Confer with operating and purchasing team members regarding procurement and stock availability
- Regularly inspect stock items for quantity, wear or defects
- Assists with the preparing of products and equipment for shipping
- Cleans maintains and organizes supplies, tools, equipment and storage areas to ensure ready access and compliance to safety regulations
- Safety sensitive position
- Assist with building maintenance as necessary
