- Ensure personnel are fully trained and qualified to handle the tasks assigned.
- Develop or update company procedures to ensure compliance with new and existing regulations and company policies.
- Monitor risk-management procedures and maintain problem logs for identifying and reporting issues to Management, Engineering and Sales Teams.
- Collaborate with Technical Documentation and Process Specialist to implement and manage document control and revision process.
- Identify, initiate and potentially lead improvement projects.
- Work with Purchasing Department to evaluate and maintain global list of suppliers and materials.
- Ensure products meet or exceed customer and company expectations and demands.
- Oversee other compliance and quality related responsibilities and documentation requirements, as needed.
- Provide training to staff, vendors and customers, as needed.
